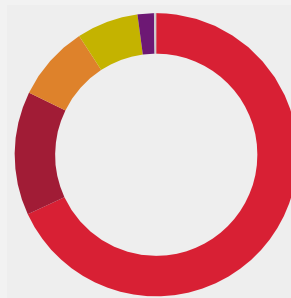

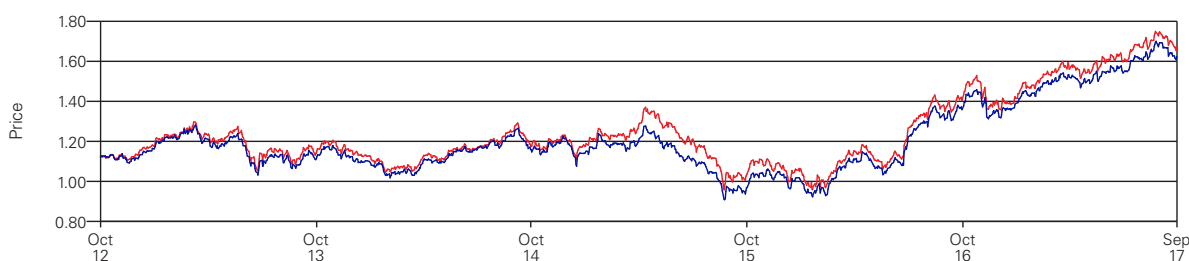

market commentary

Emerging markets rose over the quarter as robust economic growth in China and the US boosted investors' appetite for riskier assets. Investors also interpreted Janet Yellen's comments on 'gradual' interest rate increases to be positive for developing countries. However, the US Federal Reserve's (Fed) decision to reverse its stimulus programme and geopolitical tensions between the US and North Korea weighed on sentiment. Chinese stocks rose on the release of encouraging manufacturing data and the launch of a bond trading link. In Latin America, Brazilian equities advanced on continued economic reforms by President Michel Temer, although corruption allegations against him raised some concerns. Elsewhere, Russian shares gained in line with stronger oil prices. Against this backdrop, stocks in the energy, information technology and materials sectors advanced.
