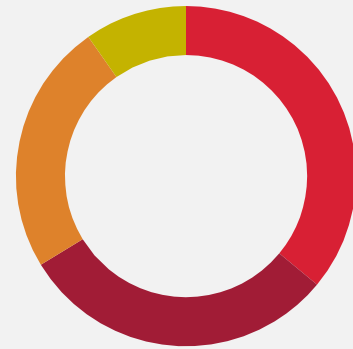

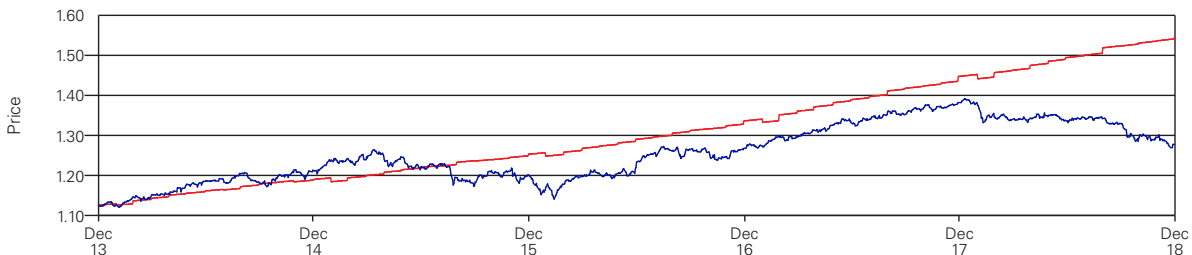

## market commentary

Global equity markets fell over the quarter and ended 2018 in negative territory. During the quarter, concerns about the global economy and the interest rate hike by the US Federal Reserve (Fed) weighed on investor sentiment. Continued Brexit-related uncertainty and US-China trade tensions further concerned investors, despite the US and China reaching a 90-day truce to temporarily halt new tariffs and finalise a trade deal. On the monetary policy front, the US Fed signalled further tightening in 2019, but at a slower pace. It lowered its projections for rate hikes and economic growth in 2019. Against this backdrop, all key markets ended the period lower, with Japanese and US stocks registering a significant decline. Emerging markets also fell, but outperformed developed markets. Equities declined the most, followed by commodities and property shares. Fixed income markets posted mixed returns, with global government bonds ending the year on a positive note.

That's why putting more of your DC pension pot into bonds to try to match annuity prices as you get closer to retirement age can help protect against this risk.	High
