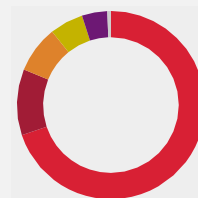

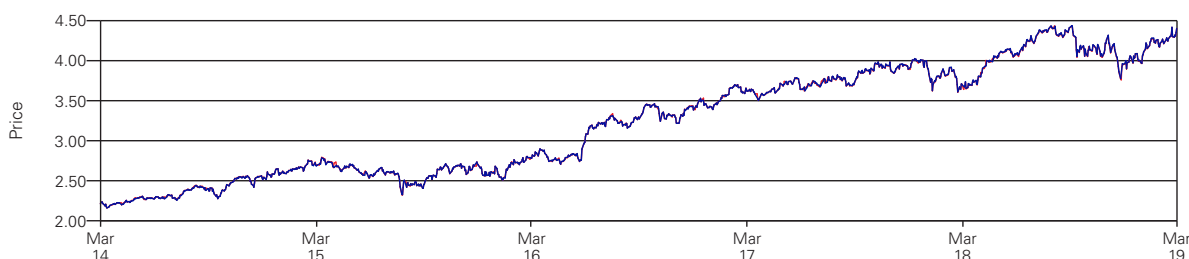

## market commentary

Global equities generated positive performance over the first quarter of 2019 as the risk-off sentiment seen in the fourth quarter of 2018 receded. The accommodative monetary policy in major economies, progress on US-China trade talks and healthy corporate earnings supported equity markets. Notably, the US Federal Reserve (Fed) signalled a possible end to interest rate hikes in view of rising global economic risks. The European Central Bank announced the launch of a targeted subsidised lending programme in September 2019 and pushed back guidance for future interest rate hikes. China also announced measures such as a reduction in banks' reserve requirement ratios and tax cuts to support growth. Meanwhile, the UK delayed Brexit after politicians rejected deals to withdraw from the European Union. Against this backdrop, all key markets ended higher, with equities in the US and Pacific ex Japan rising significantly. Emerging markets also performed well, but lagged developed markets.
