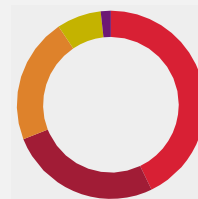

market commentary

Equities in the Asia Pacific ex Japan region started the period on a subdued note. The US-China trade dispute deepened, with both countries imposing new tariffs on each other's imports. However, investor confidence received support towards the end of the quarter amid monetary policy easing around the globe and optimism around the resumption of China-US trade talks in October. Overall, equities in the region declined over the quarter. Chinese stocks underperformed regional equities during the quarter. South Korean markets trended downwards amid trade tensions with Japan. Selling activity by foreign institutional investors weighed on equities in Taiwan, India and the Philippines. In Australia, positive profitability trends and new business initiatives supported sentiment towards consumer staples. At the sector level in the region, materials and industrials were the key laggards.
