

market commentary

Index-linked UK government bonds (Gilts) posted positive returns but underperformed nominal Gilts as inflation breakevens (the yield differential between nominal and inflation-linked government bonds of the same maturity) tightened. UK inflation breakevens edged slightly lower, driven by a general risk-off tone and a slump in oil prices. Ten-year Gilt yields also fell, boosted by lower US Treasury yields and as Prime Minister Theresa May delayed the parliamentary vote on the Brexit deal.
