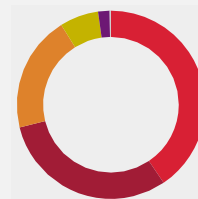

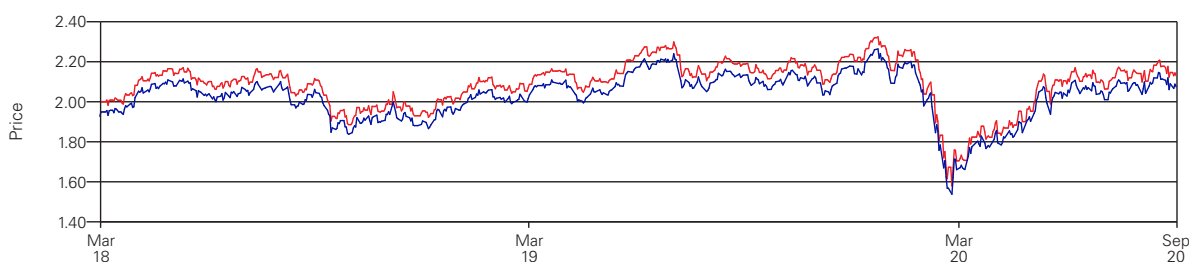

## market commentary

Regional equities rose during the quarter and recovered from March lows, supported by ample liquidity, an economic recovery led by China and optimism around the development of a COVID-19 vaccine. From a country perspective, Chinese equities rose amid improving economic data and a slew of new listings under recently announced capital market reforms. Meanwhile, Australian stocks underperformed regional equities due to weakness in energy stocks which tracked crude oil prices lower. An acceleration in digitalisation due to the pandemic supported gains in information technology (IT) stocks. Indian equities advanced as more businesses resumed operations following a further relaxation in lockdowns, despite fears of surging domestic COVID-19 cases.
