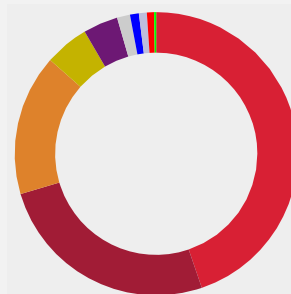

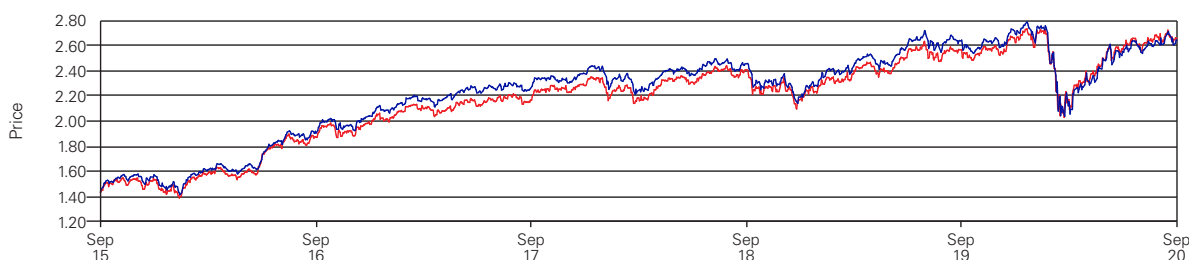

market commentary

Global equities generated positive returns, driven by signs of a recovery in economic activity and optimism around potential COVID-19 vaccines and treatments. Markets were also supported by expectations that global monetary policies would remain accommodative. Rising COVID-19 cases globally, a delay in additional fiscal stimulus in the US and US-China tensions kept markets volatile. Against this global backdrop, the US, Japan and Europe ex UK outperformed other developed markets. Emerging markets also gained and outperformed developed markets. From a sector perspective, consumer discretionary, information technology and materials delivered positive performance.
