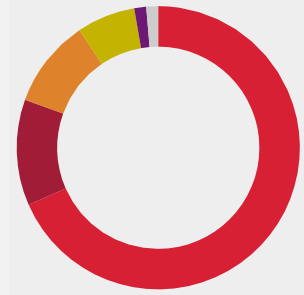

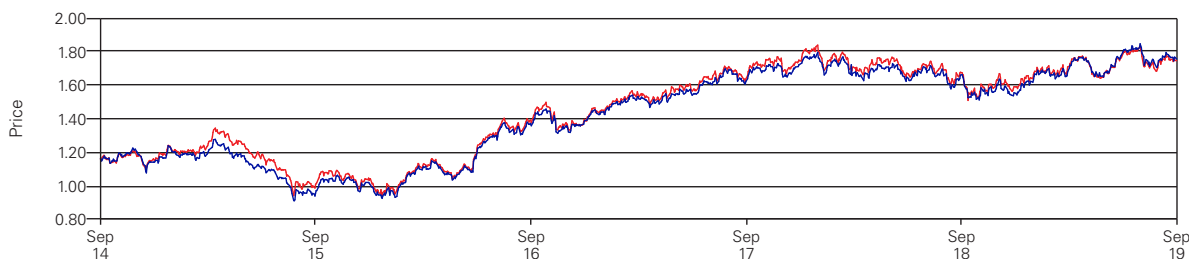

## market commentary

Emerging markets fell during the third quarter in US dollar terms but were flat in euro terms. Investors remained concerned about the deteriorating global outlook and trade tensions between the US and China. However, market gains in September offset some of these losses. Latin American equities were volatile. Argentinian shares came under pressure after incumbent President Mauricio Macri lost the primary election by a wide margin. Elsewhere, the International Monetary Fund downgraded India's economic growth projections for 2019–20 in light of subdued domestic demand. However, India's surprise move to cut corporate tax rates in September in order to lift growth provided some reassurance to investors. The Turkish market recorded gains and the lira strengthened. Despite the recent drone attack on Saudi Arabian oil facilities, oil prices settled down amid assurances of a quick restoration of capacity.
