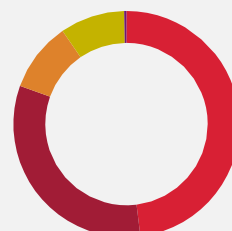

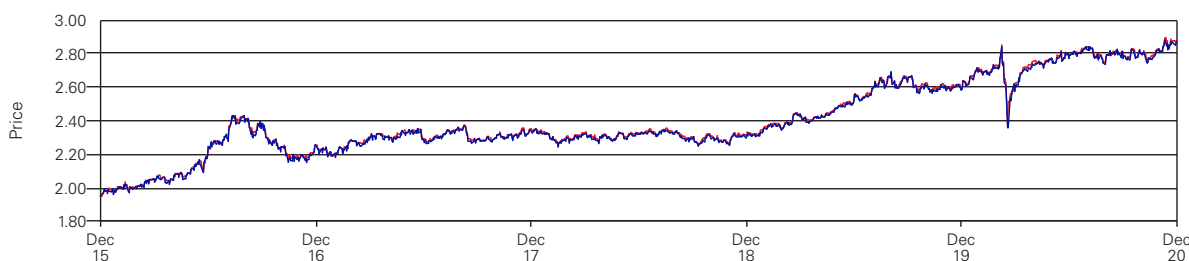

market commentary

Fixed income markets posted mixed returns over the quarter, with corporate bonds outperforming government bonds. Credit spreads tightened on hopes that COVID-19 vaccine rollouts will boost an economic recovery and ward off corporate defaults. Joe Biden's victory in the US presidential elections and the approval of a \$900 billion COVID-19 relief package by the US Congress supported the risk-on sentiment. Investor sentiment was further boosted after Brexit took full effect, as the UK left the European Union's (EU) customs union and single market, and the UK and EU clinched a post Brexit trade deal, as years of talks end in a settlement allowing for tariff-free trade. The UK manufacturing PMI increased to 57.3 in December from 55.6 in November due to rising levels of input purchases and stockpiling of raw materials during the Brexit transition period.

That's why putting more of your DC pension pot into bonds to try to match annuity prices as you get closer to retirement age can help protect against this risk.	Low
